NRS 19.035 Fees not to be charged or collected for services rendered certain governments or officers. A county clerk shall neither charge nor collect any fee for any service rendered by him/her to:

- 1. The State of Nevada.
- 2. The County of which he/she is Clerk.
- 3. Any city or town within that County
- 4. The school district of that County
- 5. Any general improvement district which is located within that county; or
- 6. Any officer of the state, that county or any such city, town, school district or general improvement district in the officer's official capacity.
