

RESOLUTION

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF LINCOLN COUNTY DESIGNATING THE NUMBER OF CENTS OF EACH ONE HUNDRED DOLLARS (\$100.00) OF PROPERTY LEVIED FOR EACH FUND AND AUTHORIZING THE LEVY OF THE TAX REQUIRED FOR THE FISCAL YEAR OF 2013-2014

Whereas, the State of Nevada Tax Commission has certified the County of Lincoln's combined tax rate; and,

Whereas, the Board of Commissioners of Lincoln County pursuant to Nevada Revised Statutes 361.460 must designate the number of cents per One Hundred Dollars (\$100.00) of property levied for each fund and authorize the levy of the tax rate required for the 2013-2014 fiscal period.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Lincoln County that the attached Exhibit A containing the designation of each fund's tax rate is adopted, and Authorization is given to levy the tax rate required for the 2012-2013 fiscal year.


